REGULATIONS

Constitution of Ecuador and the Organic Law of Human Mobility: refugees and asylum-seekers are granted access to work (in all its forms) and social-security in Ecuador, with no difference to Ecuadorian nationals.

The **Labor Code** does not make specific reference to migrant workers and although this can be considered a gap in terms of the human mobility approach, it must also be interpreted in the sense that **ALL WORKERS HAVE THE SAME RIGHTS, DUTIES AND OPPORTUNITIES.**




